Principles of Public Procurement and Property Administration</p> <p>Public Procurement and property administration shall have to comply with the following principles:</p> <p>1) Ensure value for money in the use of Public Fund for procurement.</p> <p>2) Non discrimination among candidates on grounds of nationality, religion, gender, or any other criteria not having to do with their qualification, except in cases of preference specifically provided for in this Proclamation.</p>
