- The General Experience Required for this construction work is Five (5) years and the bidder's registration with this license as Online verification shows the valid general construction license were registered on 11/7/2017 EC which is not sufficient to meet the five (5) year General experience required, three years Audit and Average annual construction Turnover.
- License attached registration date 11/11/2014 EC was not relevant license because it is Building and Water work construction.

#### Name of Bidder: - Nimona General Contractor: -

The bidder submitted Adama City Wonji Gravel Raod from ETUR to Awash River as general and Specific Experience agreement with Aklaysia General Contractor as subcontractor and the mentioned Contractor denied the case. i.e it is false presentation of experience and contractor fails to qualify what requested with letter Ref No BMJHBO/4/3/7424 dated 21/9/2027 EC to submit original agreement before or on date 30/5/2025 but can't submit on the due date. In addition, all submitted experiences are non-relevant to the specific experience required (Building and Gabion works).

#### Name of Bidder: - MASSIF General Contractor: -

Contract agreement and specific experience attached, Asella City Administration Construction of Gravel Road and closed drainage project from Arsi Zon Administration to Shell Fuel station, Contract Amount of 130,879,650.67 from 20 February 2022 to 17 January 2023 but in agreement the public body (Client) was stated as Bishoftu Administration (may be edited purposely to mispresent the experience). This implies the contractor doesn't meet the specific experience required for this work.

#### Name of Bidder: - Source General Contractor: -

- Described their company as Government Owned entity and fails to submit United nations Resolution or Borrower's Country law.
- The General Experience Required for this construction work is Five (5) years and the bidder's registration with this license as Online verification shows the valid general construction license were registered on 18/10/2013 EC which is not sufficient to meet the five (5) year General experience required.

#### Name of Bidder: - Getinet Tamiru General Contractor: -

• Fails to complete letter of bid with provided space to be filled with required information. The most and main part is bid validity period and the bidder admitted
