- No submitted work experience justified by customs and revenue for private and NGO


3. Daniel Tsegaye GC-1

- The contract agreement of Guri small scale irrigation signed on 21/01/2021 GC(13/05/2013 E.C) between Gawo Kebe Agricultural and Natural Resource office and the bidder, but the provisional acceptance was on 15/03/2012 which is contradictory, so it is a fraudulent practice
- Submitted Inconsistent work experience documents
- Average Annual construction turnover does not meet the requirement

3. Kanara Engineering PLC

- The contract amount of Chafe Hargeti small scale irrigation scheme was 11,418,648.76 but the bidder submitted as it was 19,310,142.82 which is edited and photo shopped and this indicates a fraudulent practice.
- Average Annual construction turnover does not meet the requirement

Accordingly, Massif GC PLC, MM Engineering, AL-CON WWC JV with Girma Assefa GWWC and JD General Construction have passed for further financial evaluation.
