We appreciate your feedback and take these matters seriously. After a comprehensive review by the Oromia Irrigation and Pastoral Development Bureau, along with a thorough evaluation by an independent committee, we have determined that the reasons cited for the rejection of your bid by the technical evaluation team are correct. The committee found that your company is currently facing a non-performing contract linked to the Mechitu Spate Irrigation Project. An internal memo dated July 30, 2017, explicitly states that the bureau requested termination of this contract due to significant performance issues. We are committed to resolving this matter effectively. ### Methodology

Discussion has been made how to proceed to the investigation, gathering of relevant secondary data/bid evaluation report documents related to those particular projects on which complaint has been arisen.

### Agenda:

1. To resolve contractors' complaint on bid document evaluation result of construction of Oromia Low Lands Livelihood Resilience Project II Feedstore and medium span Bridge construction projects. Accordingly, the contractor GEMTA Construction Plc submitted a complaint in letter No. GEMTA CONS/0292 dated 01/07/2025 G.C against the Hulo Medium Span Bridges Project. Similarly, the contractor Malcha Halake GC submitted a complaint in letter No. MH-GC-153 dated 02/07/2025 G.C regarding the Haran Wayu Feedstore Project.
2. To recommend remedies for the grievance rose on Haran Wayu Feedstore (ET-ORRPCU-456043-CW-RFB) and Hulo Medium Span Bridges (ET-ORRPCU-456049-CW-RFB) projects.


A short briefing about the agenda is explained by the chairperson and the participants forwarded suggestion how to start the investigation on the bidder's complaint in connection with the report of the bid evaluation committee and document submitted by the contractors.

The bid was announced on the Ethiopian Herald, as (IBRD Loan or IDA Credit No. IDA 75190, P180076 World Bank, on the date Friday 14 February 2025 for the construction of 2 Feedstore and medium Span Bridge Construction projects located in different zones which are Borena and West Harrerge of the Oromia region. Based on this, the contractors' complaints were thoroughly investigated and observation of the committee is listed in the table below.
