This letter serves as Clarification No. 2 regarding the bid documents for the project announced on January 4, 2026. Please note the following clarifications that have been made to ensure transparency and accuracy in the bidding process:

## 1. Lot-1 (Halega SSIP) Evaluation Criteria:

In the bid document, Section III (Evaluation Criteria) No. 4.2, the requirement for specific construction and contract management experience has been corrected. The criteria now require:

- At least one contract comprising irrigation system/water supply/drainage/bridge or similar water-related works with a minimum value of 34,000,000 ETB (Thirty-Four Million ETB), or
- Two contracts, where at least one contract has a minimum value of 20,000,000 ETB (Twenty Million ETB) successfully completed.

## 2. Bill of Quantities for Item No. 2.1.11.1:

The quantities for Yatu Bomba, Adada, Birbirti, Waltane, and Burka Sodu have been corrected. Only the first item (2.1.11.1) is to be considered, as the previous quantities were mistakenly doubled.

### 3. Summary of Bill of Quantities:


For Burka Sodu, Waltane, Birbirti, Adada, Yatu Bomba, Kuri Ganda Umaro, Kuri Ganda Jilo, and Obagino Denda, the summary will now include Total, VAT (15%), and Grand Total at the end of the document.

#### 4. Gedemso SSIP Bill of Quantities Summary:

The summary for Gedemso SSIP has been corrected, as the previous version was doubled. The first entry will now be considered as accurate.
