We acknowledge receipt of your claim regarding the evaluation of your bid submission for the project LOT-9 (Birbirti SSIP).

In your claim, you stated that the submitted certificate is an original document issued by the Oromia Water and Energy Bureau and suggested that the reference discrepancy was a typographical error made by the issuing Authority.

The Claim Committee has thoroughly reviewed your grievance alongside your original bid submission and has concluded the following:

Document Validity: The committee has found the submitted certificate to be a misleading document. It is the sole responsibility of the bidder to ensure that all submitted documentation is accurate, valid, and free of critical discrepancies prior to submission.

Financial Capability: Upon evaluation, your average annual turnover falls below the minimum requirement explicitly stated in the bidding documents.

Clarification Policy: Per standard procurement guidelines, submitting full, clear, and unambiguous documentation is a mandatory requirement for all bidders. The procuring entity is under no obligation to request clarifications for foundational discrepancies or failures to meet core qualification criteria.

Final Decision: Based on the objective evidence within the submitted bid document, the Claim Committee stands by its finding that the document is misleading and that the financial requirements were not met. Therefore, your claim is hereby rejected, and the original evaluation decision is upheld.
