Dear Sir/Madam,

We acknowledge receipt of your claim concerning the technical evaluation of your bid submissions for the projects LOT-5 (Kuri Ganda Umara) and LOT-7 (Adada SSIP).

In your grievance, you asserted that the Letter of Bid, Bid Security, and Environmental/Social compliance documents were fully available and compliant within your submitted bid packages.

The Claim and Grievance Committee has thoroughly re-examined your submissions against the explicit requirements set forth in the bidding documents. Please find our findings and observations detailed below:

Claim Committee Findings & Observations

Letter of Bid (Incomplete and Altered): Upon detailed review, the submitted Letter of Bid was found to be incomplete. Mandatory blank spaces that should have been fully completed by the bidder were left blank. Furthermore, the committee observed that the Letter of Bid had been altered, and the required name of the proposed Adjudicator was not inserted.

Environmental & Social Compliance: The proposal failed to meet the mandatory compliance standards as the required Code of Conduct for each staff member was not attached to the bid document as strictly specified in the requirements.

Bid Security Flaws: While a bid security instrument was physically provided, a critical evaluation revealed that the submitted Bid Security was not specific to the construction of these designated projects. A valid bid security must explicitly reference and bind itself to the specific scope and title of the project under tender.

Due to structural omissions in the Letter of Bid, missing personnel Codes of Conduct, and a non-project-specific Bid Security, your proposals fail to meet the essential criteria.

Based on these objective compliance failures, the original evaluation results are upheld, and your claim is hereby rejected.
